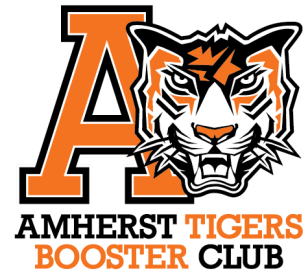


## **Amherst Tigers Boosters Meeting**
